FOR SURVIVORS 2024



OVERVIEW

Voting is a fundamental right, but for those experiencing stalking or abuse, the process can present unique risks and challenges. This guide is designed to help survivors and their loved ones navigate the voting process safely and confidently. It provides information on each state's programs and options that can help protect survivors' privacy and ensure their voices are heard. These include:

Address Confidentiality Programs (ACPs): These programs allow survivors to withhold their addresses from all public records, including voter registration lists. Participants are given a free substitute mailing address, which can be used in place of their physical address on public documents. This helps protect survivors from being located by current or former abusers through publicly available voter registration records.

Confidential Registration: Typically linked with ACPs, confidential registration is also available as a standalone option in some states, as an alternative or additional way for survivors to safeguard their personal information when voting.

Early Voting: Early voting allows people to cast their ballots in person before Election Day. This option may be beneficial to survivors who want to avoid the crowds or whose whereabouts may be monitored by their abuser on Election Day. It can allow them to vote with more flexibility, at a time that is safest for them.

Same-Day Registration: Same-day registration allows individuals to register and vote on the same day, including on Election Day. This option provides flexibility to survivors who miss the registration deadline or would prefer to register in person to avoid leaving a digital or paper trail at home.

Voting by Mail: Also known as no-excuse absentee voting, this option allows voters to receive and submit their ballots by mail, eliminating the need to attend a polling place in person. It provides a secure alternative for survivors who may not be able to visit physical voting sites or would feel safer voting from home.
